#### Discussion: -

The I.Q.A.C. coordinator welcomed all the members for the discussion of the agenda. The following points were discussed in the meeting: -

### Agenda no. 1:

The proceeding of the last meeting (meeting no. 33) was read by the I.Q.A.C. coordinator and confirmed by all the members, with the following suggestion: -

- The IQAC has instructed the Nodal Officer of the Autonomous Committee, Sri R.K. Mishra, along with the committee members Dr. Pramod Kumar and Dr. Sweta, to collect complete information regarding the process of becoming autonomous through various autonomous colleges and official websites. They are directed to prepare a proper plan and make a list of the requirements needed for this work. A meeting has been scheduled to be held on 31.10.2025 to discuss these matters. Need to fulfil the required procedure to process for Autonomous and for this, prepare a proper plan.
- It was suggested by the Educationist member of the IQAC, Dr. Ganganand Singh, that the prepared IQAC schedule needs to be made a little more detailed.
- Due to the weak BSNL connectivity currently being used, and to improve Wi-Fi connectivity
  in the college, Sri Arun Kumar has been instructed to provide the college with information
  related to Jio Air Fibre connection or another network supplier agency.
- Teachers need to focus on the field of research.

### Agenda no. 2:

After confirmation of the last meeting (meeting no. 33), A rough ATR has been presented in today's I.Q.A.C. meeting and finalised with the above suggestion.

#### Agenda no. 3:

All the cell nodal officers of the IQAC criteria have been instructed that the deadline for data submission is 30.11.2025. #### Agenda no. 4:

## Agenda no. 5:
